

Ohio's Distracted Driving Law-

Although not specifically related to QCWA, here in Ohio we now have a law intended to reduce accidents, injuries and death caused mainly by drivers who insist on texting or reading their mobile phones while driving. As I've mentioned here and in the ARRL *Ohio Section Journal*, there is an explicit exemption for FCC licensed amateur radio operators.

The bill is incorporated in Ohio Revised Code § 4511.204 (Driving while texting). The ham radio exemption is in Paragraph H, immediately following section f. I suggest you print out this law, highlight the exemption, and keep it in your glove compartment, just in case you get stopped while operating mobile.

Chapter Member Jeffrey Meyer, K4DKW, Brings Amateur Radio to Elementary Schools



Jeff Meyer, K4DKW, moved to the Painesville area a couple of years ago with an idea to introduce amateur radio to school children. He reached out to the area public schools but found no interest from the higher ups. So, Jeff brought his message to the Catholic Diocese of Cleveland, where he received a positive response. K4DKW summarized his efforts below.

"As for Communion of Saints and St Aloysius, they are both progressing nicely. Communion of Saints ARC took second place in the Feb 2023 School Club Roundup and with a few more QSO'S would have finished first. The other club is going well but the head count is smaller and it's going to need more time to grow.

The Ohio School for the Blind and Deaf club is moving forward and I should be putting up the needed dipole and starting them up in the next 2 weeks.

Both schools are very pleased with my program and I'm planning to continue through the end of May at both schools. The Diocese has been very supportive, and to date has generated a podcast, a magazine article and posted a video of us doing the SCR contest, with much acclaim.

We also brought in Phil Sakal, one of the Channel 5 Meteorologists, to give Communion of Saints a mini SKYWARN program, for grades 4 to 8. The kids liked it and the club got some additional exposure by sponsoring it.

That's a lot for a first year for any club with most of the kids coming back next year."

The First Modern Receiver I played With; The National NC-270 in 1975 by George J. Misic, KE8RN

In 1965, I started working on Saturdays at Bernie's Ham Shack at 2118 East 21st Street in Cleveland, Ohio. This was a great opportunity for a fairly new radio amateur. I was first licensed on November 22, 1963, the day President John F. Kennedy was assassinated. I had the opportunity to try out many different pieces of ham radio equipment.

The first receiver I used that had a product detector for SSB, Automatic Gain Control [AGC] on SSB, and very smooth tuning with a flywheel built into the tuning knob was the National NC-270, which was traded in on a new Galaxy V transceiver. The receiver had good selectivity for SSB, CW, and AM; the selectivity operated with conventional inductive and capacitive components at 230 KHz; a National development. National built many receivers using the 230 KHz last IF including the well



respected HRO-500 solid state receiver first released in 1964. Both the NC-270 and HRO-500 use only L-C components to get good selectivity at 230 KHz; no crystal lattice or mechanical filters were used. The NC-270 was finished in National's dramatic color they called "cosmic blue." It only weighed 28 pounds and was only 15.75 inches wide.

The NC-270 covered 80/75, 40, 20, 15, 10, and 6 meters; 160 meters was not included. The NC-270 included a built-in 100 KHz crystal calibrator; the calibrator works quite well on

80/75 to 10 meters; on 6 meters, the calibrator is difficult to use because it was difficult to tell if you had the right 100 KHz mark. The family of National receivers the size of the NC-270, including the NC-190, and NC-140 general coverage receivers, and the NC-155 ham band receiver all had a flip foot to tilt the receiver up when flipped down; when flipped up and out of the way, the receiver sat level.

At Bernie's, we sold the very fine Galaxy V 80/75 to 10 meter transceiver and the Galaxy III 80/75 to 20 meter SSB-CW transceiver. We also sold the sadly, largely forgotten, Transcom SBT-3 75, 40, and 20 meter solid state SSB transceiver plus Hammarlund receivers. I found the used National NC -270 receiver to outperform the Hammarlund HQ-110A amateur band receiver which did not have a product detector for SSB or CW. The HQ-170A may have outperformed the National NC-270, but they were very close to each other; the National dial mechanism worked so well. I personally preferred it.

Sadly, Bernie Bernon died at the young age of 54 in 1967. I worked with his widow, Eunice Bernon, K8ONA and bookkeeper to close out the store. I applied at Pioneer-Standard Electronics amateur radio and commercial sound department at 5403 Prospect Avenue and was hired there. They sold Drake, Collins, Hallicrafters, Swan, and National and picked up Ten-Tec and Signal One when they became available in 1968-1969.

Answer to Riddle: Because it would be a foot.
